#### **Rules:**

The Family Golf Pass is for the exclusive use of the designated players listed on this form. Guests of the designated players will be charged green fees based on the current posted rates. Driving Range privileges are NOT included in the Family Golf Pass. Pace of Play rules are in effect: Passholders will be expected to maintain the posted Pace of Play of 2 hours 10 minutes for 9 holes. Reduced Driving Range rates are available for Passholders; Prices are listed below.

Family Pass Holders who play outside of this schedule will pay regular green fee rates. The Pass Holder is NOT a member of Lakeside Golf Club and does not share in any of the member privileges.
